Intent

To help us abstain from compulsive eating and compulsive food behaviors by appreciating the moment, especially mealtime, and not living a distracted lifestyle.

Implementation

Update the Business Conference Policy Manual. The Conference-Approved Literature Committee would develop a segment on the tenth Tool, mindfulness, for *The Tools of Recovery* pamphlet. The tenth Tool would be added to relevant OA print literature as it becomes depleted and new supplies are ordered, and would be added immediately to online resources (ex. *Suggested Meeting Format*). Articles would be written for *A Step Ahead* and *Lifeline*.

Cost

Minimal, except for the cost of an additional page in *The Tools of Recovery* pamphlet.

Rationale

Food is not our enemy, nor is mealtime something to be rushed through while distracted. In the past food was used as a defense mechanism to stuff down feelings and pain; now it is a source of nutrition and health. Mealtime can still be enjoyed and be pleasing when mindful techniques are practiced.

The purpose of an OA Tool is to help us abstain from compulsive eating and compulsive food behaviors. "Mindfulness" may do that by helping OA members become aware of and appreciate their food, and help remove any past stigma possibly associated with weight loss or dysmorphia.

There are many ways to become mindful and this Tool can be as varied as our members. The point is to slow down, bring our Higher Power into our mealtime, and know that we are no longer hurting ourselves with food.

The Tools are mentioned or listed in at least five books and five pamphlets, which will need inserts added to explain the updated number of Tools and name of the new Tool. Then another insert that includes the text of the new Tool would need to be placed in these publications once it is created. Otherwise it is confusing when the information changes from one publication to another. This process would take several years as the existing pamphlets and books are reprinted and reviewed.

- Staff time ensuring the inserts are provided
- Staff time to update pages of oa.org

The following Conference and board committees be restructured as follows, to begin with the 1992 WSBC:

- 1) The Conference committees listed in Subpart B, Article XI of the Overeaters Anonymous, Inc. Bylaws should confer with the corresponding board committees.
- 2) Committee membership will be limited to a delegate cochairman, a trustee cochairman, and two or more delegates from each region, up to thirty members at WSBC. Additionally, a combination of up to six former trustees, current trustees, and nondelegate members may be appointed to participate in the work of the committee during the year.
- 3) Cochairmen consisting of a Conference delegate (elected by committee members at WSBC) and a trustee (appointed by the chairman of the BOT) will coordinate the efforts of the committee. The Conference delegate cochairman will preside over the committee meetings at WSBC. Intent

To find ways to reach truly substantial unanimity through discussion at WSBC.

Implementation

The Board of Trustees would decide how to do this, but presumably it would establish an ad-hoc committee to do the investigation and make the proposals.

Cost

The cost might include purchasing some books that provide consensus-building alternatives to *Robert's Rules of Order* and communicating with other twelve-step fellowships.

Rationale

Concept Twelve (c) encourages us to find ways of making decisions that ensure substantial unanimity. This proposal suggests that we examine methods of ensuring substantial unanimity and focuses on our primary purpose as set out in Tradition Five of carrying the message of recovery to those who still suffer.

Our current method of decision making:

- Uses *Robert's Rules of Order*, a book that in its most recent revision contains over 600 pages of rules on how to make decisions, which it is safe to say very few delegates attending WSBC have read in its entirety;
- Requires a non-OA parliamentarian to advise the person who chairs on how to deal with motions and points of order and amendments using *Robert's Rules of Order*;

- Requires a center microphone monitor who advises delegates on how to navigate the intricacies of *Robert's Rules of Order*;
- Uses a method of debate on motions that:
  - Pits pros against cons without providing for the input of persons who are undecided but have concerns and want to provide their input;
  - Limits the discussion of all motions to a limited number of debaters regardless of the relative importance or nonimportance of a particular issue; and
- Uses a method of changing and amending proposals that:
  - Involves complex rules of how to amend and what can be amended;
  - Uses a Reference Subcommittee with its own rules to find ways to resolve policies.

This method of decision making has had the following impacts:

- Although logical and traditional, it is complicated and requires specialized knowledge to navigate it (as evidenced by the need for a parliamentarian and a center microphone monitor).
- Debate about the proper procedures (whether something is a proper amendment to an amendment, or whether something is a point of personal privilege or point of order, or what takes precedence over that) can overshadow discussion of important matters relating to carrying the message of recovery to those who still suffer.
- Rather than encouraging substantial unanimity through consensus building, it ultimately puts issues up to votes, which can leave a significant minority dissatisfied with the outcome.
- It can inhibit developing simple ways to come up with creative policies that might arise from a spirited discussion of a motion but are not proper amendments according to *Robert's Rules of Order*.

The primary purpose of every OA group, including the World Service Business Conference, is, as set out in Tradition Five, to carry its message to those who still suffer. The primary focus of every annual WSBC should therefore be how well we have carried our message in the past year and how we can improve carrying our message in succeeding years.

The World Service Business Conference is the group conscience of Overeaters Anonymous. According to Tradition Two, our ultimate authority is “a loving God as He may express Himself in our group conscience.” *Robert's Rules of Order* works well for groups that have people with strong opinions and that require clear decisions. The WSBC method of decision making should reflect trust in our Higher Power and not fear that we are so divided that we need *Robert's Rules of Order* to make decisions.

There are many methods of group consensus development which encourage creativity and free-flowing discussion, including a recent book which offers many helpful suggestions. Other twelve-step fellowships have also developed their own methods of achieving substantial unanimity which involve opportunities for creative discussion prior to formal adoption of policy motions.

This motion asks the Board of Trustees, as our trusted servants, to investigate those methods and come back to the WSBC with motions that would hopefully help ensure the WSBC to find creative ways to develop consensus and substantial unanimity.
